



Membership Agreement

I, the undersigned, hereby agree to adhere to and fulfil the Terms and Conditions outlined below, including but not limited to:

1. **Joining Fee and Initial Payment:** I agree to pay a joining fee of \$50 upfront, along with my first week's membership payment.

2. **Minimum Term and Cancellation:**
 - I acknowledge that my membership is subject to a minimum term, and that my membership and associated payments will continue until I provide a minimum of 30 days' written notice by completing the Focus Fitness cancellation form.
 - If I wish to terminate my membership before the end of the contract's minimum term, it is my sole responsibility to find a replacement and pay a transfer fee of \$50. If I am unable to find a replacement, I agree to pay an early cancellation fee of up to \$250 or the remainder of my contract term, whichever is greater.

3. **Direct Debit Payments:**

Direct debit payments will be processed on the days you have selected. If a payment is reversed, the reversed amount will be added to your outstanding balance and debited from your account on the subsequent scheduled payment day. It is your responsibility to ensure that sufficient funds are available in your account. Please be aware that each reversal of a direct debit will incur a late payment fee of \$14.95



4. Overdue Payments:

- If my payments become more than 30 days overdue, the remaining balance of the minimum term will be due immediately and may be forwarded, along with my personal information, to a Debt Collection Service. Collection costs will be added to the outstanding balance.

5. Club Etiquette and Conduct:

- While on the premises of Focus Fitness, I will adhere to the unstaffed 24-hour access rules and club etiquette as displayed. Focus Fitness reserves the right to terminate my membership for non-compliance with these rules. I will also take care to avoid causing any damage to the facility and agree to be responsible for any damage caused by purposeful destruction.

6. Management Rights:

- Focus Fitness management reserves the right to approve new memberships and terminate existing memberships, including those of past members who owe money or were terminated for other reasons.

7. Booking Cancellations:

- I will provide no less than 12 hours' notice for the cancellation of bookings or appointments with Focus Fitness onsite service providers. Failure to do so may result in charges equivalent to their standard session rates.



8. Non-Usage of Facilities:

- Non-utilization of gym facilities does not exempt me from paying my membership fees, nor does it entitle me to a credit or refund.

Membership Hold:

- My membership may be placed on hold by Focus Fitness under the following conditions:
 - If I am traveling overseas or medically impaired.
 - The hold period will be from a minimum of 1 month to a maximum of 3 months, subject to the presentation of valid travel or medical documentation.
 - During the hold period, a maintenance fee of \$15.96 per month will be applied in lieu of the standard membership fee.

9. Personal Training and Valuables:

- While on Focus Fitness premises, I will not engage in personal training sessions with individuals not contracted with Focus Fitness without first obtaining written permission from management.
- If I choose to store personal valuables onsite or in lockers, it will be at my own risk. I will not hold Focus Fitness responsible for any loss or damage to such items. The locker service provided is for casual use only while I am onsite working out.



10. Guest Access:

- If I hold a "Focus Ultimate" membership, I am entitled to bring one guest at a time to use the facilities free of charge, subject to the following conditions: a. Guest access is limited to hours during which the club is staffed. b. Guests must be 18 years of age or older, or at least 14 years of age if accompanied by a parent or guardian. c. I am responsible for ensuring that my guests comply with all terms and conditions of this agreement. I acknowledge that failure to comply may result in the refusal of access to or expulsion of the non-compliant guest.
